This release addresses the following Service Requests:

Service Requests 83662, 83667

AFT has notified the University of their desire to increase the Dues/Fees for represented employees in the IX and LX Units. For both Dues and Fees, deduction percentage is to be increased from 1.35% to 1.5% of Total Gross. AFT also requested that the Due/Fees Cap for represented employees in the IX and LX Units be increased from \$65.00 to \$75.00. These same changes apply to the CO charities. There are to be no changes to unrepresented/non-represented members. Service Request 83662 asks PPS to implement these changes effective with May 2012 earnings.

CUE - IBT has notified the University of their desire to increase the Dues/Fees for represented employees in the CX Unit. For Dues, deduction percentage is to be increased from .50% to .80% of Total Gross. For Fees and CO Charities, deduction percentage is to be increased from .475% to .775% of Total Gross. Service Request 83667 asks PPS to implement these changes effective with May 2012 earnings.

Table Updates

Benefits Rates Table

SR83662 and SR83667 have provided the Benefits Rates Table transactions to update the Benefits Rates table. Locations will use these transactions to update the Benefits Rates Table (control table 14).

Installation Instructions

Execute PPP004 to update the following DB2 CTL table with release transactions.

- Benefits Rates Table (14) – Use the transactions in CARDLIB (BRTPROD).
- Benefits Rates Table (14) – Use the transactions in CARDLIB (BRTPROD2).

Timing of Installation

The timing of this release is **Date Mandated**.

The supplied Benefits Rates Table update transactions must be applied to the control tables after the final computes for April and prior to the first compute for May 2012 earnings.

As usual, campuses are encouraged to install this release in as timely a fashion as possible and in the normal numeric sequence.

As always, these updates should be applied to production data only as approved by your campus Payroll Manager.
