1 Overview

To adjust the rates for qualified parking for tax year 2016.

1.1 Background

The Internal Revenue Service issued Revenue Procedure 2015-53 on October 21, 2015 which included the annual inflation adjustments for tax year 2016.

For the tax year 2016, the monthly limitation under IRC Section 132(f)(2)(A) regarding the aggregate fringe benefit exclusion amount for transit passes and transportation in a commuter highway vehicle remains at \$130. The monthly limitation under 132(f)(2)(B) regarding the fringe benefit exclusion amount for qualified parking in 2016 is \$255, up from \$250 in 2015.

1.2 Objectives

Update the PPS System parameters Table to reflect the 2016 rate changes for the qualified parking (076 FED and 077 SWT).

The rate change is effective January 1, 2016. The new rates are effective for wages paid on and after January 1, 2016. These updates must be applied to the control tables after the last compute for December 2015 earnings and prior to the first pay compute for 2016.
